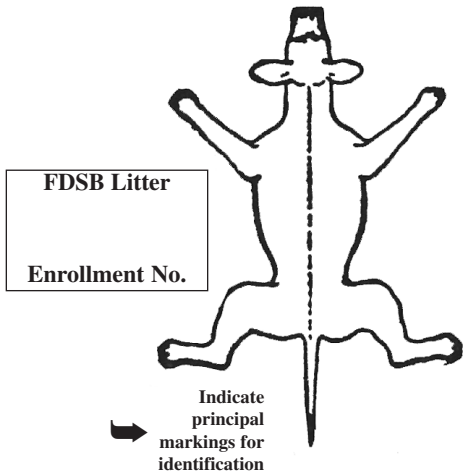

The *Field Dog Stud Book* registers ALL BREEDS of dogs, records names, colors, age, pedigrees, sex; Records Transfers of Ownership and Enrolls Litters.

RULES GOVERNING REGISTRATIONS

APPLICATIONS for individual dogs must be made on separate *Field Dog Stud Book* forms. Registration and Litter Enrollment blanks furnished on request.

NAMES REGISTERED—Each application shall be filled out completely. Names selected must not exceed *three* words or initials, and are restricted to 20 letters. Numerals or Jr. are permitted only after names of sons and daughters consecutively and are counted as words. The right is reserved to substitute another name in case names submitted are duplications or confusing. The certificate signed by the owner or lessee of dam at time of service on the face of this form must be completed in full. Registration fee: \$20.00.

LITTERS ENROLLED—Application must be made on enrollment form. Enrollment simplifies subsequent registration of individuals and assures a permanent record of litter. Certificates of enrollment are issued to owners. Fee for each litter, \$20.00 (plus \$2.00 for each puppy in litter).

TRANSFERS OF OWNERSHIP—The back of each registration certificate provides a form to endorse transfer of dog named on the face thereof. Transfers should be recorded promptly. Fee for transfer: \$20.00.

CHANGES OF NAMES—Fee: \$20.00. Original certificate, showing transfer or change of name, must be sent to *Field Dog Stud Book* for recording. After entry a new certificate will be issued to owner. Changes of names permitted for period of *one year* from date of original registration.

DUPLICATE REGISTRATION CERTIFICATE will be issued only in the name of recorded owner on receipt of information that the original has been lost or destroyed. Fee: \$20.00.

STRIKING DOGS FROM THE RECORD—Should a dog have been admitted to registration, a litter enrolled or ownership transferred through the misrepresentation or fraud, the AMERICAN FIELD PUBLISHING COMPANY, on discovery of same, reserves the right to declare the registration, enrollment, or transfer void, together with any entries that may have been made of any descendants of such dogs.

By publication of registration by The AMERICAN FIELD, the public is enabled to detect fraud or error, and to enter protest. Anyone responsible for fraud or misrepresentation shall, at the discretion of the AMERICAN FIELD PUBLISHING COMPANY, be debarred from registering thereafter. Furthermore, the privilege is reserved to exclude breeding of doubtful authenticity and to decline registrations of dogs emanating from any person or kennels known to have given false information regarding pedigrees of dogs.
